THE PROGRAM MAY HAVE LOOKED DIFFERENT AS MASKS, TEMPERATURE CHECKS AND COHORTING CONTINUED AS THE NORM FROM THE ESSENTIAL CHILD CARE PROGRAM, BUT OUR STAFF AGAIN WENT ABOVE AND BEYOND TO PROVIDE AN ENRICHING PROGRAM FOR 12 WEEKS OF SUMMER. THIS PROGRAM GAVE A PIECE OF MIND TO THOSE WHO WERE ESSENTIAL WORKERS AT THE HEIGHT OF THE PANDEMIC.

DURING THE FALL 2020 SEMESTER THE YMCA CONTINUED TO OFFER REMOTE LEARNING CHILD CARE (NOW KNOWN AS ADVENTURE ACADEMY) TO FAMILIES WHO NEED CARE WHEN SCHOOLS OR DISTRICTS MOVED TO REMOTE LEARNING. THIS PROGRAM CONTINUED INTO THE SPRING 2021 SEMESTER AS MANY DISTRICTS ANNOUNCED A DELAYED RETURN TO SCHOOL PLAN. OVER 300 KIDS SPENT OVER 2,000 HOURS IN THE ADVENTURE ACADEMY PROGRAM.

AS DISTRICTS HAVE TRANSITIONED BACK TO IN-PERSON LEARNING THE YMCA HAS CONTINUED TO PROVIDE BEFORE & AFTER SCHOOL PROGRAMMING AT 31 SCHOOLS IN THE PIKES PEAK REGION ACROSS 6 DISTRICTS AND 5 CHARTER SCHOOLS. THE LANDSCAPE OF THESE PROGRAMS HAS CHANGED DRASTICALLY DUE TO COVID.

FAMILIES ARE CONTINUING TO FACE QUARANTINE, REMOTE LEARNING AND OTHER CHALLENGES AND OUR YMCA TEAM IS WORKING TIRELESSLY TO PIVOT AND SUPPORT EACH OF THE UNIQUE NEEDS OF THE FAMILIES AND THE SCHOOLS.
